Emergency appointments, farm, and trailer slaughter arrangements can be made if needed. Any non-standard process should be notified at appointment scheduling (i.e. horned cattle, injuries, etc.). Emergency, farm, trailer, and non-standard slaughter processes, including cleaning of dirty animals, are subject to additional fees and will be assessed on order invoice(s).
